

## Green Clean Schools Act – Public Act 095-0084

<b>What is Green Cleaning?</b>	Green Cleaning simply means <i>cleaning to protect health without harming the environment.</i>	
<b>What will this act do?</b>	This act will require all elementary and secondary schools in Illinois to purchase only environmentally sensitive cleaning supplies. The Green Government Coordinating Council defined environmentally preferable in the <i>Green Cleaning Act Guidelines and Specification.</i>	
<b>What are the cleaning product purchase requirements under the law?</b>	<u>Cleaning Product Category</u> <ul style="list-style-type: none"> <li>• Bathroom Cleaners</li> <li>• Carpet Cleaners</li> <li>• General Purpose Cleaners</li> <li>• Glass, Window &amp; Mirror Cleaners</li> <li>• Hand Cleaners &amp; Hand Soaps</li> <li>• Paper</li> </ul>	<u>Certifications</u> <ul style="list-style-type: none"> <li>• Green Seal</li> <li>• Environmental Choice EcoLogo</li> <li>• U.S. EPA Design for the Environment Formulator Program</li> <li>• U.S. EPA Comprehensive Procurement Guidelines for Commercial and Industrial Sanitary Tissue (<i>Paper Only</i>)</li> </ul>
<b>What else is included in the Guidelines?</b>	Schools are encouraged to adopt comprehensive green cleaning programs. The Guidelines include recommendations for preferred products that are not covered by the requirements including air fresheners, chrome cleaners, degreasers etc. The guidelines also include equipment recommendations as well as best practices.	
<b>Do I need to dump my existing cleaning products?</b>	No, you don't need to throw away your existing inventory of supplies. This law specifically states that "a school may deplete its existing cleaning and maintenance supply stocks and implement the new requirements in the procurement cycle for the following school year."	
<b>What about disinfectants?!</b>	The Guidelines give <i>recommendations</i> on environmentally preferable disinfectants but does not supersede any existing public health laws.	
<b>When is this going into effect?</b>	<p>Public Act 095-0084 was passed into law on August 13, 2007.</p> <p>February 1 - will appear in Illinois Register</p> <ul style="list-style-type: none"> <li>• Comment period (45 days)</li> <li>• Second comment period (45 days)</li> <li>• Guidelines become finalized May 9, 2008</li> </ul> <p><a href="http://www.standingupforillinois.org/green/gs_schools.php">http://www.standingupforillinois.org/green/gs_schools.php</a></p>
