Sept. 1, '08 (filed by then, and by Sept. 1 of each year)	Sept. 1, '08 (filed by then, and by Sept. 1 of each subsequent year)	Council	The Council shall be responsible for reporting annually to the Governor and the General Assembly on the results of environmental sustainability actions taken by State agencies, educational institutions and units of local government during the prior calendar year. The report must include the environmental and economic benefits of the environmental sustainability actions, where feasible, the consumption of those actions, and provide recommendations for future environmental improvement activities during the following year.
